## Authorising person's acknowledgements

By signing the present Bank's Power of attorney, the Authorising person confirms, that he will recognise the following provisions to be binding to himself and the Authorised person:

- The Authorised person has been introduced to the provisions of the Agreement and undertakes to comply with them, has been informed about the obligations and rights of the parties, established by the Agreement, the constituent parts of the Agreement and is fully aware of the essence and consequences of the Agreement;
- The Authorising person shall recognise and fulfil the obligations assumed by the Authorised person as the Authorising person's own obligations, provided that the Authorised person has not exceeded the limits of his or her assignment (Article 2309 of the Civil Law);
- An Authorised person may not exceed the limits of the assignment given to him or her, and firstly should act in compliance with the instructions of the Authorising person (Article 2300 of the Civil Law);
- An Authorised person may commence only such activities as are required by the nature of the assignment given to him or her and is necessary in connection with such assignment (Article 2301 of the Civil Law);
- An Authorised person may not gain profit for himself or herself from the assignment, and he or she shall transfer everything he or she has gained or obtained through the authorisation to the Authorising person, except only what the Authorising person has granted to him or her from such gains (Article 2304 of the Civil Law);
- In performing the assignment given to him or her, the Authorised person shall act with utmost care and he or she shall be liable to the Authorising person for any negligence (Article 2295 of the Civil Law);
- The Bank's Power of attorney is terminated upon expiration of the period of authorisation (Article 2312 of the Civil Law) or when the Authorising person withdraws his or her power of attorney;
- The Bank's Power of attorney is regarded to be withdrawn from the moment, when the Bank receives an application from the Authorising person on Withdrawal of the Bank's Power of attorney:
- The Bank recognizes as binding to the Bank only such Withdrawal of the Bank's Power of attorney wich is correctly filled and signed by the Authorising person;
- The Bank's Power of attorney is issued without the right of the authorization.
